- 1. Contest Schedule.** Contest begins February 22, 2018 at or after 12:00:01 a.m. Pacific Time (PT) and ends May 15, 2018 at 11:59:59 p.m. PT (“Contest Period”).
- 2. Contest Theme.** Vans, a division of VF Outdoor, LLC, is celebrating our fans who are “Not Just One Thing.” Vans is looking for submissions that show us how you express your creativity and individual style through the media of photography, other visual arts, video or music.

**3. To Enter.**

**(A) At Vans Website.**

- 1) Visit the Vans website at [www.vans.com](http://www.vans.com)/enter and click on the button for the *HERE'S YOUR CHANCE TO BE IN A VANS CAMPAIGN*.
- 2) Complete the official entry form with all required information, including your name, zip code or postal code, and e-mail address.
- 3) Post an original work that you created (be it a photo, other work of visual art, video or musical piece) or a secure link to a website with your original work showing how you are *Not Just One Thing*, as prompted. If work is a photo or other work of visual art, it may be in color or black and white and cannot exceed five (5) MB; only the following file formats are acceptable for works that are photos/other works of visual art: .JPEG, .GIF, or .PNG. If work is a video or musical piece, it cannot exceed thirty (30) MB. For videos, only the following file formats are acceptable: .MP4 or .MOV; for musical pieces, only the .MP4 file format is acceptable.† You may, if you like, include a brief statementΩ about yourself along with the work itself.

- 4) Check the box indicating that you (if a minor in your jurisdiction of residence, your parent or legal guardian) have read, understand and agree to these Official Rules and then click the SUBMIT button. YOUR ENTRY WILL NOT BE ACCEPTED IF YOU DO NOT INDICATE THAT YOU HAVE READ, UNDERSTAND AND AGREE TO THE OFFICIAL RULES.

**(B) Instagram or Twitter.**

- 1) Log into your public (not private) Instagram or Twitter account and post your original work (along with a brief statement<sup>Ω</sup> about yourself, if you like) showing how you are *Not Just One Thing* with the hashtags #myvans and #contest. (BOTH HASHTAGS MUST BE INCLUDED. USE OF THE HASHTAGS SERVES TO DISCLOSE TO THE PUBLIC THAT YOUR ORIGINAL WORK WAS CREATED IN CONJUNCTION WITH YOUR PARTICIPATION IN A CONTEST SPONSORED BY VANS, A DIVISION OF VF OUTDOOR, LLC, TO ADVERTISE ITS SHOES, APPAREL AND OTHER PRODUCTS.)
- 2) IF YOU ENTER THE CONTEST BY POSTING A WORK ON INSTAGRAM OR TWITTER, YOU (IF A MINOR IN YOUR JURISDICTION OF RESIDENCE, YOUR PARENT OR LEGAL GUARDIAN) ARE ACKNOWLEDGING THAT YOU/YOUR PARENT OR LEGAL GUARDIAN HAVE READ, UNDERSTAND AND AGREE TO THESE OFFICIAL RULES. DO NOT PARTICIPATE IN THE CONTEST WITHOUT FIRST REVIEWING THESE OFFICIAL RULES.

**4. Entry Restrictions.**

- (A) All entries must be received by 11:59:59 p.m. PT on May 15, 2018.**
- (B) By participating in the Contest, you (if a minor in your jurisdiction of residence, your parent or legal guardian) agree to these Official Rules and Sponsor’s decisions, which are final and binding in all respects and not subject to appeal.**
- (C) A person may submit more than one (1) entry, provided that each work submitted as an entry is unique. Up to three (3) works may be submitted as part of a single entry. DO NOT SUBMIT THE SAME WORK MULTIPLE TIMES. Violation of the entry limit will result in only the initial work(s) being accepted; however, should Sponsor determine in its sole discretion that a given person has repeatedly, egregiously or blatantly violated the entry limit, ALL works/entries will be declared void and the person submitting such works/entries will be disqualified from the Contest.**
- (D) If you enter via the Vans website (as per Rule 3A), receipt of your entry will be acknowledged by Sponsor; but if you enter via Instagram or Twitter (as per Rule 3B), receipt of your entry *may* be acknowledged by Sponsor. Any such acknowledgment shall not constitute any representation as to Contest eligibility, a notice of selection as a potential prize winner, nor is it otherwise binding upon Sponsor. Further, should Sponsor elect to post/re-post a person’s work (as per Rule 6 below), such action shall not constitute any representation as to Contest eligibility, a notice of selection as a potential prize winner, nor is**

- (B) is inappropriate, obscene, hateful or otherwise unfit for publication;
- (C) advocates the use of alcohol or drugs, acts of violence, dangerous stunts, reckless behavior or illegal conduct;
- (D) disparages or damages the goodwill and/or business reputation of Sponsor, its endorsers or the Vans brand;
- (E) is not truthful in all material respects (in either the work itself or any accompanying statement about yourself, do NOT claim to have done something or to know someone if, in point of fact, it's actually not true);
- (F) is not related to the Contest theme of showing how you are Not Just One Thing.

## **6. Grant of Rights in Work.**

In submitting a work as an entry in the Contest, you (if a minor in your jurisdiction of residence, your parent or legal guardian) grant to Sponsor and its designees the non-exclusive, irrevocable, perpetual, worldwide, royalty-free, transferable, sublicenseable right and license to use, perform, exhibit, reproduce and/or otherwise exploit the work, and your name, photograph, image, likeness, voice, biographical information and/or any other indicia of your persona in any manner and in any and all distribution channels, venues or media now known or hereafter devised, without further notice or any compensation to you (if you are a minor in your jurisdiction of residence, or to your parent or legal guardian). The

preceding grant of rights is subject to any rights retained by Instagram, LLC or Twitter, Inc. in their respective social media platforms and/or any rights retained by a third party website hosting a linked work, to the extent applicable.

You (if a minor in your jurisdiction of residence, your parent or legal guardian) further (a) waive any “*Droit Moral*,” “Moral Rights of Authors” or similar natural rights of ownership you (if a minor in your jurisdiction of residence, your parent or legal guardian) may have in the work and (b) agree, upon the request of Sponsor and without compensation of any kind, to execute any additional documents so as to effect, record or perfect the grant of rights contemplated by this section.

If your work is determined to be a prize winner, the preceding will be entirely overridden and superseded by Rule 10 below in which you as a winner (if a minor in your jurisdiction of residence, your parent or legal guardian) assign to Sponsor any and all rights in any work submitted by you to Sponsor.

You (if a minor in your jurisdiction of residence, your parent or legal guardian) also understand and agree that (a) Sponsor has wide access to ideas, stories and other literary/artistic materials submitted to it from outside sources or being developed by its own employees and that such ideas/stories/literary/artistic materials may be competitive with, similar to (or even identical to) the submitted work and that Sponsor shall have no liability to you (if a minor in your jurisdiction of residence, your parent or legal guardian) or any third party in conjunction therewith; and (b) Sponsor does not have any duty of confidentiality or other fiduciary duty to you (if a minor in your jurisdiction of residence, or to your parent or legal guardian) relative to your work.

SPONSOR MAY POST/RE-POST SUBMITTED WORKS IN A “GALLERY” ON THE VANS WEBSITE AND PERHAPS ELSEWHERE. IN SUCH CASE, ANY POSTED/RE-POSTED WORK REPRESENTS SOLELY THE VIEWS/OPINIONS OF THE APPLICABLE PROSPECTIVE ENTRANT AND DOES NOT REFLECT THE VIEWS/OPINIONS OF SPONSOR IN ANY MANNER. ## **7. Selection Of Winners.**

(A) Sponsor will select winners in two (2) rounds of judging, with three (3) prize winners selected per round of judging. The first round of judging will take place on or about April 4, 2018, consisting of all eligible entries/works

received from the start of the Contest up until March 31, 2018 at 11:59 p.m. PT. The second round of judging will take place on or about May 17, 2018 consisting of all eligible entries/works received during the entire Contest Period. (Non-winning entries/works from the first round of judging will be retained for the second round of judging.) All judging will take place at Sponsor's offices in Costa Mesa, CA USA or another location as selected by Sponsor in its sole discretion.

- (B) In evaluating entries/works, Sponsor will use the following equally weighted judging criteria, taking into account the medium used by the entrant (including, for musical works, the length of the work) and the age of the entrant: creativity; originality; alignment with the core values of the VANS brand being *Not Just One Thing* and complementing the spirit of individuality and free thinking.
  - (C) The three (3) top-rated entries in each round of judging will be the potential prize winners. In the event of a tie, an additional judge will review the tied entries/works as per the aforementioned criteria so as to determine the potential winner(s).
  - (D) Potential winners who entered by submitting their entry via the Vans website (as per Rule 3A) will be notified via e-mail; potential winners who entered by posting their entry on Instagram (as per Rule 3B) will be notified by private message from @vans or @vanscanada (as applicable); potential winners who entered by posting their entry on Twitter (as per Rule 3B) will be notified by private message from @VANS\_66 or @VANS\_Canada (as applicable). Potential winner (if a minor in his/her jurisdiction of residence, his/her parent or legal guardian) will be required to complete, sign and return an Affidavit of Eligibility, a Liability Release and a Publicity Release (where lawful) and perhaps additional documents (e.g., confirmation of grant of rights in entry), all within three (3) business days. Authentic; Era) and (1) Custom Code redeemable by winner for one (1) pair of Vans Customs shoes. Total Approximate Retail Value of Each Prize: \$370 (USD.)

Custom Code element of prize is subject to terms and conditions of use as well as [www.vans.com/customs](http://www.vans.com/customs); without limiting the foregoing, Custom Code is not a gift certificate/gift card, must be used within one (1) year and cannot be redeemed in conjunction with any other offer/promotion/coupon/discount. Custom Code has an Approximate Retail Value of up to \$95 (USD). If actual value of corresponding pair of Vans Customs shoes is less than \$95 (USD), winner will NOT receive the difference in cash or otherwise.

Custom shoes will only be shipped to a street address in the United States or Canada (excluding Quebec Province) and shoes may be delivered via multiple shipments.

Limit of one (1) prize per family, household or address. If winner is a minor in his/her jurisdiction of residence, Sponsor may award the prize in the name of or to the winner's parent or legal guardian in its sole discretion. Vans shoes component of prize is subject to availability as to size and style. **guardian) also agrees, upon the request of Vans, a division of VF Outdoor, LLC and without compensation other than the Contest Prize, to execute all documents and take all actions deemed necessary by Vans, a division of VF Outdoor, LLC, in its sole discretion so as to effect, record or perfect the foregoing assignment of rights in the Winner's Work. Force Majeure.** If Sponsor determines in its sole discretion that the Contest – in whole or in part – cannot be conducted as originally planned due to any cause beyond its control (e.g., computer virus/bug, tampering, fraud, natural disaster, riot, strike), Sponsor may cancel, modify or suspend the Contest and make the prizes for affected round(s) of judging available to be won based on its evaluation of all eligible entries/works received for such affected round(s) of judging prior to and/or after the action taken by Sponsor or otherwise in a manner that Sponsor in its sole discretion determines is fair, appropriate and consistent with these Official Rules. **13. Dispute Resolution/Choice of Law.** To the fullest extent permitted by law, you (if a minor in your jurisdiction of residence, your parent or legal guardian) agree that:

- (a) any and all disputes regarding the Contest or these Official Rules shall be governed by the internal, substantive law of the U.S. State of California (i.e., without regard to choice of law/conflict of law rules of the U.S. State of California or of any other jurisdiction);
- (b) you (if a minor in your jurisdiction of residence, your parent or legal guardian) are subject to the personal and exclusive jurisdiction of the United States District Court for the Central District of California, Southern Division or California State court situate in Orange County, California;
- (c) you (if a minor in your jurisdiction of residence, your parent or legal guardian) waive any right of change of venue, inconvenient forum or the like;
- (d) any action will be brought by you (if a minor in your jurisdiction of residence, your parent or legal guardian) individually (NOT as part of a class action);
- (e) your recovery in any such action is limited to actual costs involved in participating in the Contest (if any), with all rights to attorneys' fees and any and all damages (including special, compensatory, punitive, consequential damages) being expressly waived.

If the preceding or any other provision of these Official Rules is determined by a court of competent jurisdiction to be invalid, illegal or unenforceable, it shall be replaced by a substitute provision that most closely approximates the original intent of Sponsor and is valid, legal and enforceable. The invalidity/illegality/unenforceability of a given provision shall not affect the remainder of these Official Rules.
